# MEMORANDUM OF UNDERSTANDING 

## BETWEEN

THE COLLEGE OF EDUCATION NAMED AFTER Z.DOSMUHAMEDOVA (URALSK, KAZAKHSTAN) AND BELGLAN EDUCATION COUNCIL (BRUSSELS, BELCIUM)


#### Abstract

In order to develop the intemational cooperation in the field of higher education, College of Education named after Z.Dosmuhamedova, represented by Director Kayrlieva Altyngul Zaksygulovna, acting under the Regulations on the one part, and Belgian Education Council (Registration number. 0563.75.38.05), represented by its Director Axana Pozdnyakova, acting under the Statute on the other part, jointly referred to as the "Parties" and individually as a "Party", have entered into this Memorandum of Understanding (hereinafter the "Memorandum") as follows:


## Article 1

The purpose of this Memorandum is to launch and to develop the common activities and to define projects of mutual collaboration between the Parties that will be further defined in separate agreements.

## Article 2

2.1 With the intention of implementing the goals of this Memorandum, the Parties have generally agreed to co-operate with each other in the following areas:

1. organisation of professional video conferences, training programmes and academic exchanges of professors, researchers, master students, for the purposes of education, educational-scientific practices and training, research both abroad and in Belgium; 2. cooperation in the preparation of highly qualified educational specialists in the fields of mufual interest;
2. cooperation in the field of online education for students and advanced professional training for educators and staff, partnership in the educational movement sCyber professorw;
3. invitation of the representatives of the Parties to give lectures, exchange of experience and information in the educational, methodological work and exchange of educational projects and programmes;
4. organizing and conducting on-line lectures by professors and administrative staff of the Parties;
5. organization of joint scientific and scientific-technological researches, including, but, with involving professonial staff;
6. organization of scientific and scientific-technical joint research, conferences, seminars, symposia, round tables, days which are devoted to the Parties and other similar scientific actions and initiatives in the field of education and science;
7. the parties show readiness to cooperate with the independent international and national organizations for participation in surveys for drawing up the academic ratings of universities (QS, THE and etc.) conducted by such organizations;
8. exchanges of publications, scientific research, educational and methodological literature, periodicals and information about ongoing activities;
9. exchange of banmers; in case of absence, placement of the links to the Panties websites;
10. informing the Parties about upcoming international fairs and exhibitions in the field of education, organized by the Parties.

## Article 3

The terms of the activities defined in the Article 2 will be determined by separate agreements between the Parties.

## Article 4

The cost and expenses to be paid in relation to any co-operation or collaboration envisaged under this Memorandum shall be subject to further detail arrangements to be agreed between the Parties as and when it shall anise.

The Parties consider attracting potential financial patners, including finds as possible.

## Article 5

This Memorandum may be amended or modified by a written additional agreement, which will be an undivided part of the Memorandum which must be properly registered and signed by the representatives of two partmers.

## Article 6

Both partmers agree to carry out these activities in accordance with the laws and regulations of the respective countries.

Disputes, arising in accordance with the Memorandum will be resolved by consultation and conversation between Paties.

The operational management in coordination and realization of the Memorandum statements will be performed by persons entitled by the both Panties.

## Article 7

This Memorandum enters into validity and effect on the day of its signing by the statutory representatives of the Parties. It shall be effective for a period of 5 (five) years and automatically prolongated for the next 5 (five) years unless it is terninated by one of the parties upon prior notice to the other in writing not later than 6 (six) months before the termination date.

The Parties will keep confidential about the information, data and documents obtained in the course of cooperation

## Article 8

This Memorandum is prepared in English in two copies, one for each Party, both having the same legal force.
